## DEPARTMENT RULES & REGULATIONS

*Local and State Rules govern this competition.*

1. **ELIGIBILITY** - Open to all Amateur Winemakers over 21 years of age who's permanent residence is within the state of California. Amateur is defined as a person who does not hold an enology degree, and who makes wine only non-commercially, without assistance from any commercial winemaking facility. No commercial wines may be entered in this competition.

### ENTRY INFORMATION

2. **ENTRY FEES** - \$10.00 per Entry | \$5.00 per Wine Label Entry
  - a. Fees are NON-refundable.
3. **ENTRY LIMIT** - None.
  - a. Exhibitors must provide two bottles of wine in each class entered.
4. **IDENTIFICATION** - Entries will be displayed during the Fair, properly label entries with the exhibitor's name, division, and class prior to delivery.
5. **ENTRY REMOVAL** - Accepted works (including sold works) shall not be removed from exhibition until the Fair closes.
6. **ENTRY RELEASE** - Entries must be picked up on release day. Entries will only be released by presenting your claim check, personal identification, or a signed letter of authorization from the exhibitor. Exhibits that are not picked up within the release time will be discarded.

### ENTRY SUBMISSION

7. Wines are to be bottled & labeled in 750 milliliter or fifth bottles, except Dessert Wines which may be entered in 375 milliliter or tenth bottles.
8. Please provide adequate information on bottle labels for wine categorization.
  - a. Percent residual sugar in the wine must be listed on the entry form.
  - b. Judges reserve the right to reclassify wines to facilitate judging.
9. The Marin County Fair or its representatives retains the right to refuse or disqualify any entries that do not meet the specifications of the rules of competition.
10. The Danish System of Judging will be used in judging for medal awards, wines will be judged by professional standards.
  - a. Each wine will be judged against established standards of commercial quality, rather than how it compares with the other exhibits. Please note that under this system, it is possible that all, or no, entries could win any given medal.
  - b. Every effort will be made to judge similar wines together.
  - c. Bottles not used in the judging may be claimed by the exhibitor at the end of the Fair.
  - d. A written critique of each wine will be made available to each entrant.

### DISPLAY

11. Installation of all items is completed by a professional team whose decisions are final. No alterations or changes (e.g. location, lighting, etc.) may be made by the exhibitor or any staff member at any time.

### PUBLICITY

12. The Marin County Fair reserves the right to photograph any work in the exhibition for educational, catalog, website, or publicity purposes.

## LIABILITY

13. The County of Marin, Marin County Fair, and/or its contractors will not be responsible for loss or damage which may occur from any cause. Any entries received damaged will not be juried.
